Travel time one-way: Loops range from 2

hours to all day.

Surface type: Unsurfaced. Some parts where

the trail follows roads are graveled.

Difficulty Level: Easy to most difficult.

Recommended Season: All year.

Water: Surrounding creeks. No potable water.

Safety: During fall season, hunting is a very popular sport. Be alert and wear bright orange and place orange on your horses.

Directions: From State Hwy 23 take Hwy 116 East of County Road 19. Turn south for 8 miles to Knoppers Ford Recreation Area. Go south, past Knoppers Ford for ½ mile to Road S30, turn left. Go approximately 1-1/4 miles to the trailhead parking area.

Trail Marking: Yellow rectangles. Markers are posted at intersections to help keep you on the trail.


